Riders with parent or guardian may be 16 years (written permission required). Boat numbers assigned during registration meeting.

**GENERAL RELEASE, WAIVER AND HOLD HARMLESS AGREEMENT:** By signing this release and waive of rights, I am giving up my right to sue the Plattsburgh Bass Club, our sponsors, New York Bass Federation, FLW and TBF and releasing them and holding them harmless even from the effects of their own negligence, for any personal injuries I may sustain while participating in said tournament. If someone intentionally injures me, the release will not prevent me from suing them or making a claim for personal injuries. This release is intended to be binding upon my spouse, my estate, my personal representative and/or my beneficiaries or dependants. I understand that there is good and valuable consideration for the making of this release. I understand that I am giving up the right to sue members of the Plattsburgh Bass Club, their sponsors, New York Bass Federation, FLW and/or the TBF and that they are giving up the right to sue me. I understand that I do not need to sign this release, waiver and hold harmless agreement, and that I am not forced to sign this release and waiver. However, unless I sign this waiver, intending it to be binding, I cannot participate in the fishing tournament conducted 8/29/2010.

Advance registrations are encouraged as this event will only be available to the first 150 applicants. All participants will be required to attend the pre tournament registration meeting to be held after the FLW Series weigh in on August 28<sup>th</sup> 2010 at Dock Street Landing between 4 & 6PM.
